## SECTION 2 – HAZARDS IDENTIFICATION EMERGENCY OVERVIEW:

This is a cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

### POTENTIAL HEALTH EFFECTS:
