### **SECTION 2 - HAZARDS IDENTIFICATION**

#### **EMERGENCY OVERVIEW:**

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

#### **POTENTIAL HEALTH EFFECTS:**

- **Eye:** Contact may cause mild, transient irritation. Some redness and/or stinging may occur.

Aqua (Water, Eau) Hexyldecanol , Glycerin, Cetyl Alcohol, Stearic Acid, Cetearyl Alcohol, Dimethicone, Polysorbate 60, Propylene Glycol, Butylene Glycol, Chamomilla Recutita (Matricaria) Flower/Leaf Extract, Diazolidinyl Urea, Larrea Divaricata Extract, Benzalkonium Chloride, Carbomer, Hamamelis Virginiana (Witch Hazel) Water, Bisbolol, Sodium Hydroxide, Alcohol, Lecithin, Iodopropynyl Butylcarbamate.

### **SECTION 4 - FIRST AID MEASURES**
