4. FIRST AID MEASURES

4.1	First Aid:	<p>Ingestion: If ingested, do not induce vomiting. If product has been swallowed, drink plenty of water or milk IMMEDIATELY. 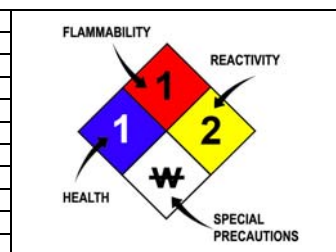
