

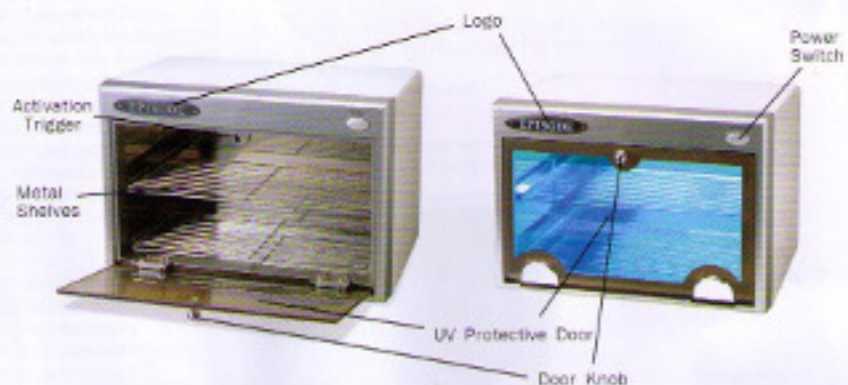
### Product Features

### How to Use

1. Plug in the unit 110V outlet.
2. Open the door and place the implements on the metal shelves.
3. Check if the door is closed and press the power button.
4. It takes approximately 30 seconds to 5 minutes to disinfect the implement. Therefore remove the implement for use after this time period.
5. Turn off the unit when it is not being used.

Caution

1. Please unplug the unit before cleaning

5. Please do not obstruct the UV light to maximize disinfection
6. Frequent pressing of power button may shorten the life of the UV bulb
7. Direct exposure to UV light may be harmful to the eyes and the skin
8. Please do not try to repair the unit yourself
9. Please do not use this product outside the professional salon environment.

## Limited Warranty

Episode UV sanitizer has underwent rigorous quality inspection process. The following is extent of the limited warranty

1. J&A USA Inc. warrants to the end user customer that the product will be free from defects in materials and workmanship for 1 year, which duration begins on the date of purchase by the customer
2. J&A limited warranty covers only those defects that arise as a result of normal use of the product, and does not cover any other problems, including those that arise as result of
  - a. Improper maintenance or modification

  - c. Unauthorized modification or misuse

If J&A USA Inc. receives, during the applicable warranty period, notice of a defect in any product which is covered by J&A warranty, J&A shall either repair or replace the product, at J&A's option
