4. FIRST-AID TREATMENT

5. FIRE-FIGHTING MEASURES

Heat the wax in a wax warmer until the wax is liquefied and apply with a spatula at low temperature. Clean tools, equipment, counters with wax cleaner, oil or alcohol. Store product in cool area.

For professional use only. Heat product at lukewarm temperature. Must be completely melted and viscous. Optimal temperature 160°F -165°F. Test inside of wrist for comfort. Do not apply on skin if product is very liquid or smoky. Product can cause serious burns if temperature exceeds 200°F).
