**SECTION 2: HAZARD IDENTIFICATION**

**POTENTIAL HEALTH EFFECTS:**

- **Eye**  
Contact may cause mild irritation. Some redness and/or stinging may occur.

### **SECTION 3: COMPOSITION AND INGREDIENTS**

Purified Water (aqua), Sodium Laureth Sulfate, Cocamidopropyl Betain, Alfa Olefin Sulfonate, Polyquaternium-7, Sodium Chloride, Fragrance, Citric Acid, FD&C Red, Yellow, and Blue, Disodium EDTA, DMDM Hydantoin.

### **SECTION 4: FIRST AID MEASURES**

- **Eye**

Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.

- **Skin Problem**

Discontinue use of product. Apply cold compress to affected areas to relieve any discomfort. If discomfort persists, contact a physician.
