CAUTION

BULBS CAN BECOME HOT DURING USE. CARE SHOULD BE TAKEN TO AVOID CONTACT BETWEEN THE SKIN AND BULBS.

ALWAYS TURN OFF THIS UNIT WHEN NOT IN USE. ALLOW THE UNIT TO COOL BEFORE CLOSING THE DRAPED DOOR.

NOTE: Cleanse the skin before commencing skin analysis.

This device is intended for use during skin analysis. The use of filtered black light illuminates various skin conditions ordinarily invisible to the naked eye. The draped door allows you to perform analysis without the use of a darkroom. A concave mirror inside allows the client to observe the analysis.

OPERATION

- A. Set the unit on a stable table or surface.
- B. Lift the draped door by pulling gently at the bottom. Be sure to lift the door up until it locks into
- C. Turn on the unit by pressing the power button.D. Instruct the client to position the head and neck inside the draped area.
- E. Using the viewing window to view the client's skin condition(s). NOTE: Use the color indicator chart as reference.

White Fluorescence	Thick corneum layer.
White Spots	Horny layer of dead skin cells.
Blue-White	Normal healthy skin.
Light Violet	Dehydrated/ dry skin.
Yellow/ Orange	Oily areas, comedones.
Pink	Oily areas, comedones.
Brown	Pigmentation problems.

F. When analysis is complete, turn the unit off; wait for the bulbs to cool; close the draped door.

TROUBLESHOOTING

When machine fails to work properly, use the following directions to detect the cause of the problem:

- A. Check the power cord for proper connection.
- B. Make sure the power switch is in the ON position.
- C. Check the power source by connecting another electrical appliance to the AC outlet.D. If the problem persists, please contact your dealer for assistance. To prevent an electrical shock, PLEASE DO NOT REMOVE ANY ELECTRICAL COVERS.
