Limited Warranty for ASME Pressure Vessel

Mr.Steam warrants that the ASME Pressure Vessel contained in its CU Products are warranted against defects in workmanship and materials for a period of five years from the date of Mr.Steam's invoice to its purchaser.

Mr.Steam will repair or replace (at its option) a CU Product if it fails to conform to these limited warranties. All warranty work will be performed without charge when the CU Product is returned to the location designated by Mr.Steam within the applicable warranty period.

Terms, Conditions, and Exclusions

This limited warranty is non-transferable and applies only to the original purchaser. This limited warranty does not apply to a CU Product which is sold "as is" or in a damaged condition. This limited warranty does not apply to repairs or replacement necessitated by any cause beyond the control of Mr.Steam including, but not limited to any malfunction, defect or failure caused by or resulting from unauthorized service or parts, improper maintenance and/or problems arising due to local water conditions, operation contrary to furnished instructions, damages occurring during shipment, transit, storage or handling, or arising from modification, or repair by any person not authorized by Mr.Steam, abuse, misuse, neglect, accident, incorrect power line voltage, fire, flood, or other Acts of God. Proof of purchase (original sales receipt) identifying the model number and serial number must accompany all warranty claims.

Returns will be examined by Mr.Steam. If in the judgment of Mr.Steam the defect in workmanship or materials is not subject to the limited warranty, any returns or repairs thereafter made shall be at the request and expense of the original purchaser.
